Contractor reserves the right to terminate this Participating Addendum if at any time it is determined that Purchasing Entity is not eligible to purchase under this Participating Addendum.

3. Purchase Order Instructions: All Purchase Orders and any other ordering documents under this Participating Addendum will be governed by the terms and conditions of this Participating Addendum and the Master Agreement including, without limitation, the obligation to pay Contractor for Products provided. Contractor and the Participating Entity (together the “Parties”) acknowledge and agree that orders submitted to Contractor from a Purchasing Entity through the Purchasing Entity’s Business Procurement Card are authorized Purchase Orders under the Master Agreement.

All Purchase Orders issued by Purchasing Entities under this Participating Addendum shall include a reference to this Participating Addendum and the Master Agreement, number MA152.

4. Individual Customer: Except to the extent modified by this Participating Addendum, the Participating Entity and each Purchasing Entity will be responsible for compliance with the terms and conditions of the Master Agreement, and will have the same rights and responsibilities for their

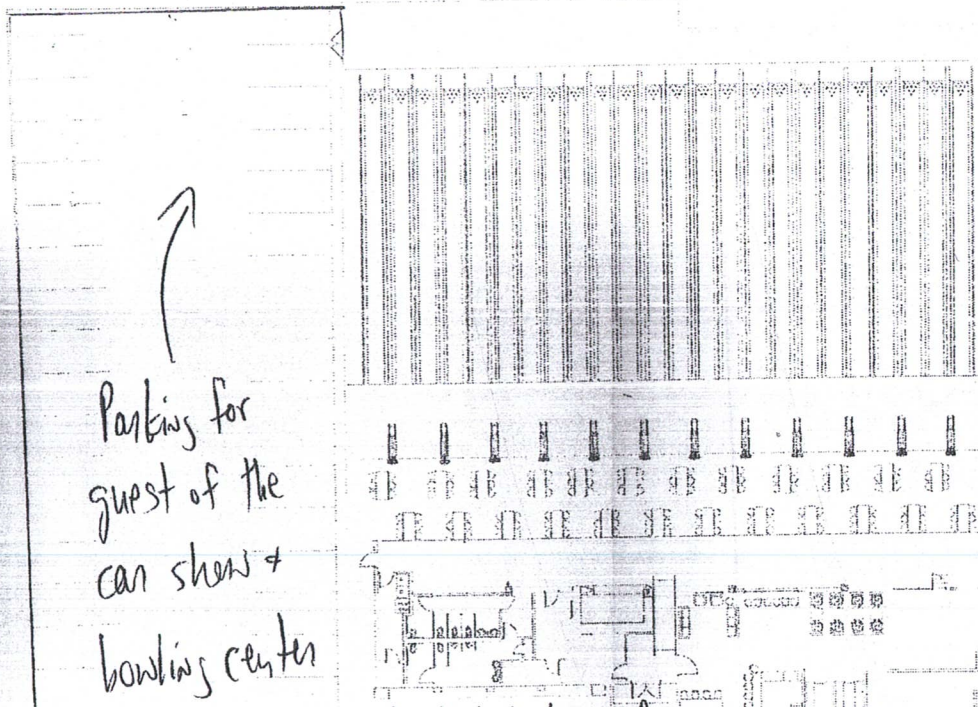

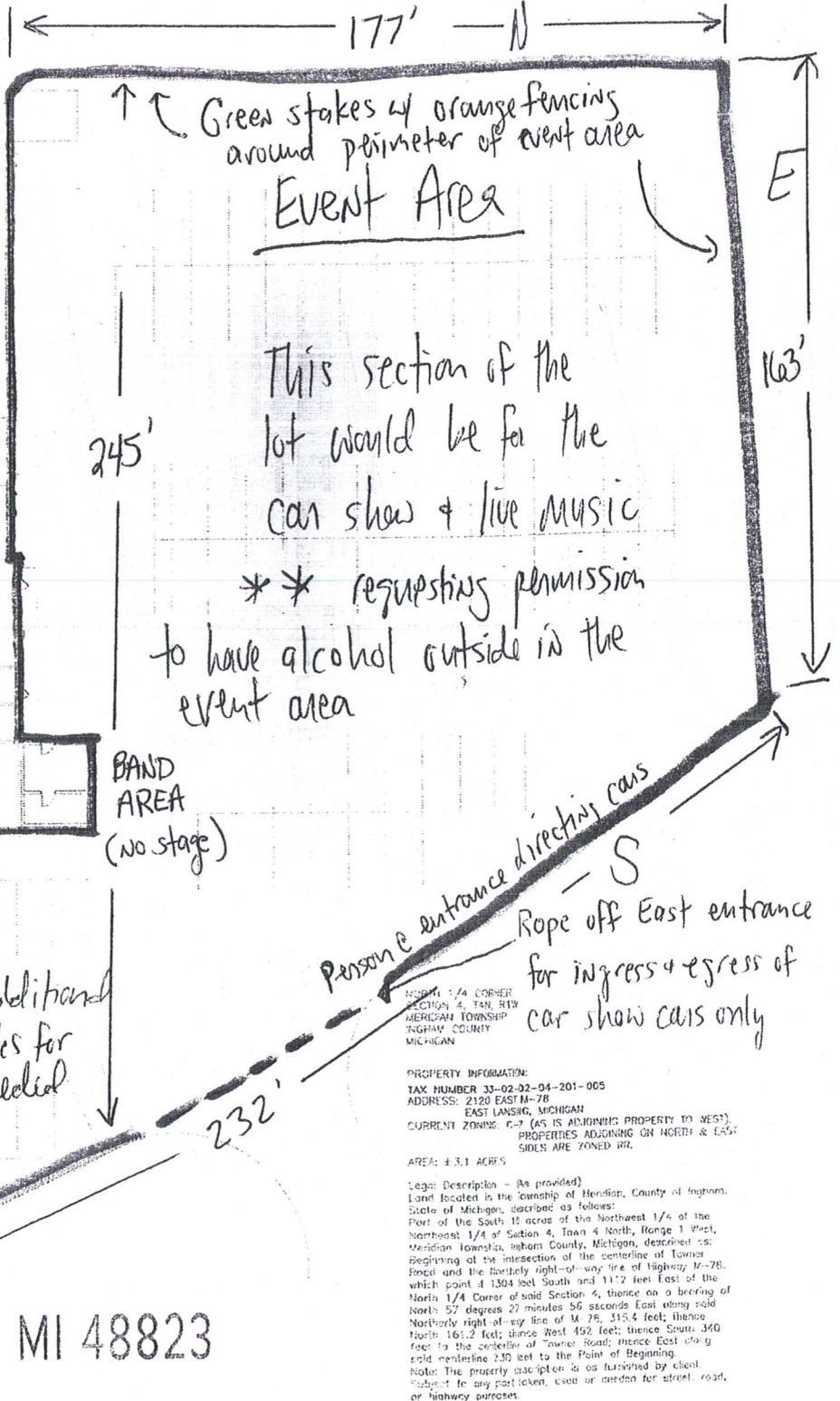

**Re: Text Amendment #2026-05 - Chicken Ordinance Updates -
RECONSIDERATION**

At the June 16, 2026 meeting, the Township Board approved Text Amendment 2026-05 to amend the districts in which backyard chickens were permitted to include nearly every place a single-family home could be built. This was a direct response to a homeowner request and it has already been well received in the community.

Since adoption, Staff has already had several homeowners come in and apply for backyard chickens under the new ordinance. One homeowner, however, applied for and began construction on their chicken coop, without realizing they are in the RN, Village of Nemoka Mixed Residential District, which was not included in the update. The RN district is only located in the area between Lake Lansing, Marsh Road, Haslett Road, and Lake Lansing Park South and is designed to allow flexibility in use, since this area has some of the older structures in the Township and there are small apartment buildings right next to single family homes. Staff contacted the resident within hours of discovering the issue, but substantial work had already been done. After talking to the resident, Staff began researching options to assist the homeowner.

The ordinance currently limits backyard chickens to only single-family homes and only within the existing single-family districts. The RN district allows for single-family home construction, so it could be added to the backyard chicken ordinance and still meet the intent of the ordinance. In talking to the Township Attorney's office, the easiest way to do this, since the ordinance has not been published for adoption yet, would be to reconsider the approval from the June 16, 2026 meeting. Should the Board reconsider the previous approval, the Board could then direct Staff to publish the amended ordinance, including the RN district. This would be amending the Planning Commission's recommendation, something the Board can do without sending the ordinance back for further discussion. Staff has prepared the following motions, should the Board choose to move forward with this action.

Move to reconsider the resolution to approve Text Amendment #2026-05 to amend the Code of Ordinances of the Charter Township of Meridian at Section 86-368 to update the standards for the keeping of backyard chickens and rabbits in the Township.

The secondary motion would be then be:

Move to adopt the amended resolution approving for reintroduction Text Amendment #2026-05 to amend the Code of Ordinances of the Charter Township of Meridian at Section 86-368 to update the standards for the keeping of

backyard chickens and rabbits in the Township, adding the RN, Village of Nemoke District to the list of districts where backyard chickens and rabbits are permitted.

Staff looks forward to the further opportunity to discuss this matter with the Board and potentially make further changes to this popular ordinance.

ORDINANCE NO. 2026-05

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CHARTER TOWNSHIP OF
MERIDIAN AT ARTICLE IV, DISTRICT REGULATIONS, TO UPDATE THE STANDARDS FOR THE
REGULATION OF CHICKENS AND RABBITS IN SINGLE-FAMILY RESIDENTIAL DISTRICTS

THE CHARTER TOWNSHIP OF MERIDIAN ORDAINS:

Section 1. Section 86-368(b)(8), RR District: One-Family Rural Residential District, is hereby amended to read as follows:

Raising and keeping of chickens and rabbits as nonagricultural use. Male chickens, also known as roosters, are permitted by right only on parcels exceeding five (5) total acres. Roosters are not permitted on parcels within the Urban Services Boundary.

The raising and keeping of chickens and rabbits accessory only to one-family dwellings in the RAAA, RAA, RA, RB, RX and RN zoning districts is subject to the following requirements:

a. Registration.

1. Prior to the raising and keeping of chickens and rabbits on any property under this section, the property shall be registered with the Department of Community Planning and Development.
2. Only an individual living in a dwelling on the property shall raise or keep chickens and rabbits on the property. A registration may not be transferred.
3. Notwithstanding registering with the Township, private restrictions on the use of property shall remain enforceable and take precedence over the registration. Private restrictions include, but are not limited to, deed restrictions, condominium master deed restrictions, neighborhood association bylaws, and covenant deeds. The interpretation and enforcement of the private restriction is the sole responsibility of the private parties involved.

b. Standards. In addition to registering with the Township, the raising and keeping of chickens and rabbits accessory only to one-family dwellings in the RAAA, RAA, RA, RB, RX and RN zoning districts shall comply with the following standards:

1. In no case shall the maximum number of chickens and rabbits in any combination exceed four. Only chickens of egg laying age and/or rabbits older than three months shall apply to this ordinance.
2. Roosters shall not be allowed.
3. The sale of chickens, rabbits and eggs on the property is prohibited.
4. Chickens and rabbits shall not be kept in any location on the property other than in the rear yard as defined by the zoning ordinance.
5. Chickens and rabbits shall be provided with a covered structure and must be kept in the covered structure or an adjoining fenced area at all times. Covered structures and fenced areas used for the raising and keeping of chickens and rabbits are subject to all provisions of Chapter **86** (zoning), except the covered structure and fenced area shall be set back a minimum of 10 feet from a side or rear lot line and structures propose for reverse

frontage lots shall be located no closer than 30 feet to the right-of-way of the designated rear yard.

- 6. All structures for the raising and keeping of chickens and rabbits shall be constructed so as to prevent rodents or other animals from being harbored underneath, within, or within the walls of the structure.
- 7. All feed and other items associated with the raising and keeping of chickens and rabbits shall be kept in containers or otherwise protected so as to prevent access to or contact with rodents or other animals.
- 8. The covered structure used to house the chickens and rabbits and any fenced area shall be kept in a sanitary condition.
- 9. This section shall not regulate the keeping of chickens in those areas zoned RR (Rural Residential) or AG (Agricultural) where the raising of chickens is a permitted use when conducted in compliance with the Michigan Right to Farm Act and the generally accepted agricultural and management practices promulgated therein.

Section 2. Validity and Severability. The provisions of this Ordinance are severable and the invalidity of any phrase, clause or part of this Ordinance shall not affect the validity or effectiveness of the remainder of the Ordinance.

Section 3. Repealer Clause. All ordinances or parts of ordinances in conflict therewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

Section 4. Savings Clause. This Ordinance does not affect rights and duties matured, penalties that were incurred, and proceedings that were begun, before its effective date.

Section 5. Effective Date. This Ordinance shall be effective seven (7) days after its publication or upon such later date as may be required under Section 402 of the Michigan Zoning Enabling Act (MCL 125.3402) after filing of a notice of intent to file a petition for a referendum.

A request was received from the property owners of Sanctuary #2 for maintenance of streetlights within the Sanctuary #2 plat. The developer of the Sanctuary #2 plat paid Consumers Energy to install four (4) 47-watt LED streetlights with Traditional fixtures with cut-off, and standard fiberglass poles along Fresno Lane. This streetlight special assessment district (SAD) will fund the ongoing maintenance and electrical service cost of the streetlights.

The proposed first year cost for streetlighting in Sanctuary #2 is \$1,457.76 (\$208.25/lot) and the cost annually thereafter will be \$728.88 (\$104.13/lot) (subject to annual adjustments).

At its March 3, 2026 meeting, the Township Board held the first of two public hearings to hear objections to the improvement, cost estimate, and assessment district. The Township Board also adopted resolution #3.

A request was received from the property owners of Sierra Ridge #4 for maintenance of streetlights within the Sierra Ridge #4 plat. The developer of the Sierra Ridge #4 plat paid Consumers Energy to install four (4) 47-watt LED streetlights with Traditional fixtures with cut-off, and standard fiberglass poles along Fresno Lane. This streetlight special assessment district (SAD) will fund the ongoing maintenance and electrical service cost of the streetlights.

The proposed first year cost for streetlighting in Sierra Ridge #4 is \$1,457.76 (\$104.13/lot) and the cost annually thereafter will be \$728.88 (\$52.06/lot) (subject to annual adjustment).

At its March 3, 2026 meeting, the Township Board held the first of two public hearings to hear objections to the improvement, cost estimate, and assessment district. The Township Board also adopted resolution #3.

This evening we are bringing resolution #4 to the Board to set the second and final public hearing for August 18, 2026.

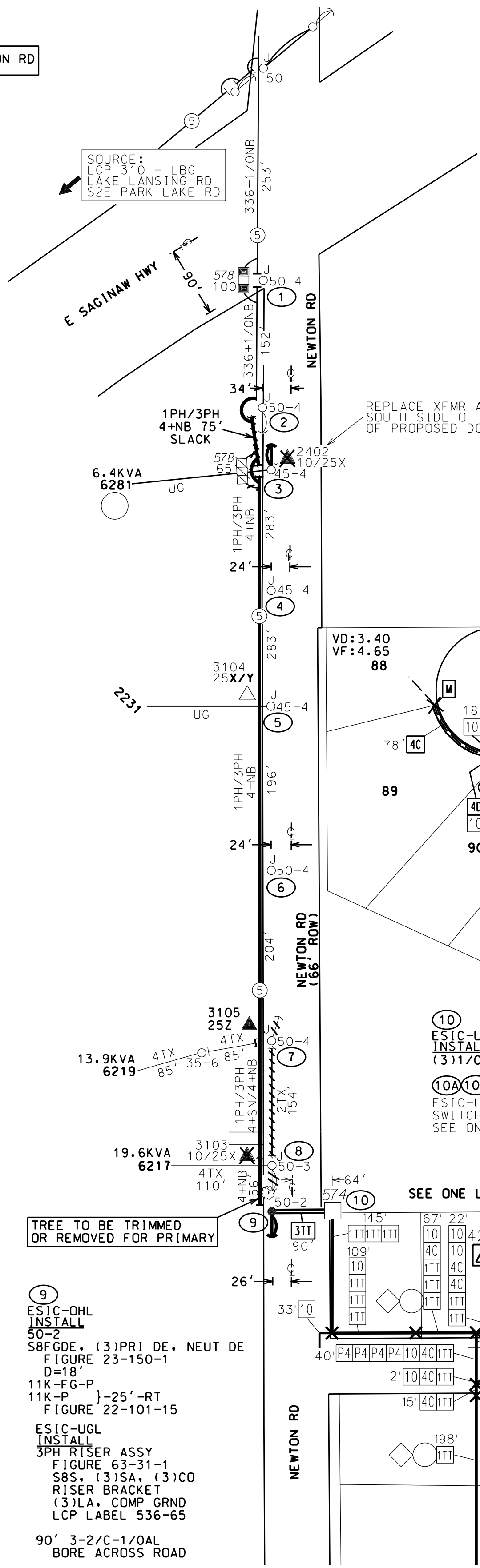

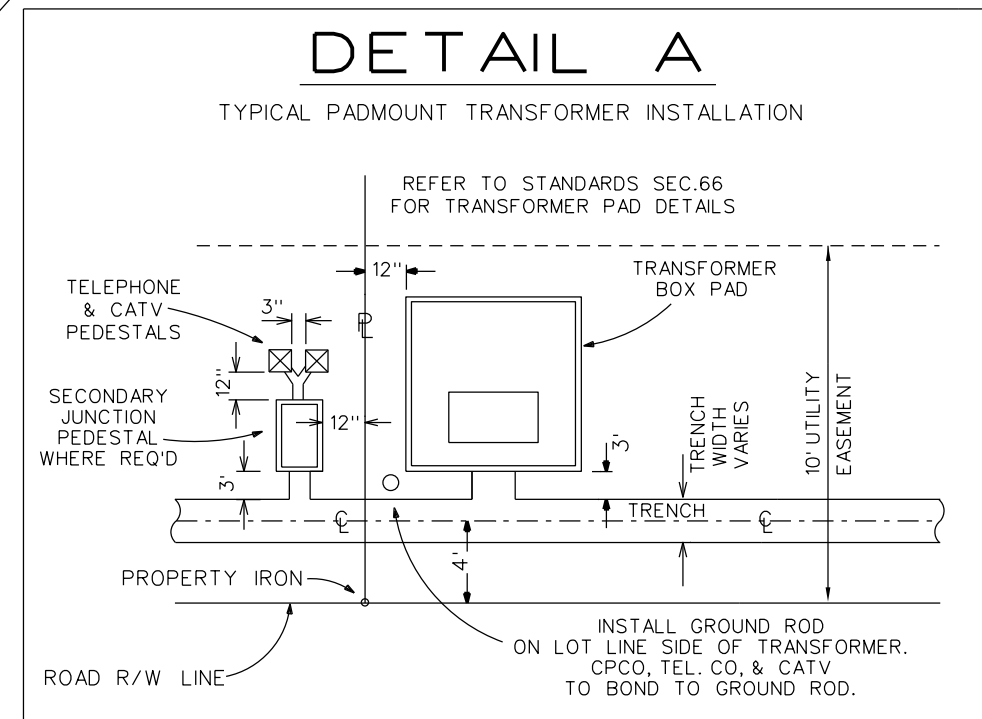

At the March 3, 2026, Township Board meeting, staff reviewed the status of Township millages. The Park Millage expired in 2025 and the 2017 Police and Fire Millage expires this year. Both millages are essential for providing critical services that Township residents rely upon daily.

Park Millage

The Park Millage (0.6522) generates just over \$1.5 million annually to enhance, operate, and maintain Township parks. This millage has been in place since 1984 and is only exceeded in duration by the Township’s General Operating Millage (1959) and Pathways Millage (1974). These funds are essential to maintaining the 30 parks throughout the Township’s system—providing critical support to staffing and operations. For Fiscal Year 2026 (2025 millage), the Park Millage Fund expenses are allocated as follows:

The Township did let a 0.3160 mill Park Millage levy expire in 2016 to help offset the increase of the 2017 Police and Fire Millage by just over 21%.

Police and Fire Millage

The 2017 Police and Fire Millage (1.4606) generates just over \$3.4 million annually to address long-term pension liabilities, provides four additional staff members for the Police (2) and Fire (2) Departments, and supports ongoing public safety equipment needs. Additional Police and Fire pension contributions have been \$1.5 million per year, with an additional \$684,000 in 2021-2022. In 2017, when this was originally adopted, the Township’s overall pension was funded at 56%, today it stands at 76%. While the funding ratio has improved, the Township does continue to accrue pension obligations that require ongoing investment.



Specifically, this millage was critical in being able to replace our two fire engines in 2024 and 2025, our ladder truck in 2022, and three ambulances in 2019, 2022, and 2026. This millage has also helped replace additional equipment and vehicles used by our first responders to serve the community.

If this millage is not renewed, we would likely see our Insurance Services Office (ISO) fire rating score decrease. An ISO fire rating is a score provided to fire departments and insurance companies by ISO. The score reflects how prepared a community is to suppress fires. If our ISO fire rating score decreases, [the cost of homeowners' insurance in the Township would likely increase.](#)

Combined, these two millages will generate approximately \$4.9 million in revenue for the current fiscal year. For context, the 2017 Police and Fire Millage represents just over 15% of all general fund revenue. The public safety millage is just over 18% of the combined \$18.5 million Police and Fire budgets. Losing one or both millages would have significant, negative impacts on the Township's operations and fiscal stability. It would require eliminating positions, we would no longer be able to replace some of our Police and Fire equipment and vehicles (including fire engines), and would significantly impact operations.

As shared during the March 3 meeting, it was my strong recommendation that the Township Board consider placing these millages before voters for renewal. During that meeting, it was the consensus of the Board to bring these back for consideration during the summer and in time for placement on the November ballot. The deadline for submitting election ballot wording for the November General Election is Tuesday, August 11, 2026, at 4 pm.

The table below shows approximately how much a property owner currently pays annually for these two millages. Many property owners who have lived in their home for an extended period would pay less than the figures shown below as their taxable value is less than half of their market value due to the cap imposed by Proposal A of 1994:

Millage Highlights

- Parks Millage expired in 2025 (0.6522 mill)
 - Generates \$1.5 million annually
 - Used to fund park improvements, operations, and maintenance
- Public Safety Millage expires in 2026 (1.4563 mills)
 - Generates \$3.4 million annually
 - Used to fund police and fire staff and needed equipment
 - Significant additional pension contributions to reduce the Township's long-term pension liability. The Township's funded status for the pension system has increased from 56% to 80% since 2017 as a result.
- Both millages also support the Motor Pool for respective departments

 - Two additional firefighters hired in 2018 with millage resources
 - Supports hiring quality firefighters
- Support national best practices (NFPA 1710) for staffing levels and response times:
 - Four minutes for initial arriving fire engine at fire
 - Eight minutes for full complement of 16 firefighters minimum at structure fire



Fire Department

- Insurance Services Office (ISO) rating that assigns a public protection classification to jurisdictions base on fire department services.
- Meridian Twp. is a Class 3 ratings (1 being the best, 10 the lowest)
- A higher community protection factor helps reduce insurance rates
- Evaluation factors:
 - Staffing
 - Response times
 - Annual training
 - Equipment, including ladder trucks and engines
 - Water supply, including public system



Parks Department

- Thirty parks, recreational facilities, and extensive programming requires significant staffing, 13 full-time and multiple part-time staff, including:
 - Director and Administrative Assistant
 - Parks and Land Stewardship Superintendent
 - 6 Full-time Utility Workers (maintenance) and
 - 5 Part-time Seasonal Maintenance Workers
 - 2 Recreation Specialists
 - Market Manager and Assistant Manager
 - Stewardship Coordinator and 4 Part-time Stewardship Assistants
 - 1 Senior Naturalists
 - 7 Part-time Assistant Naturalists
 - 1 Recreation and Policy intern

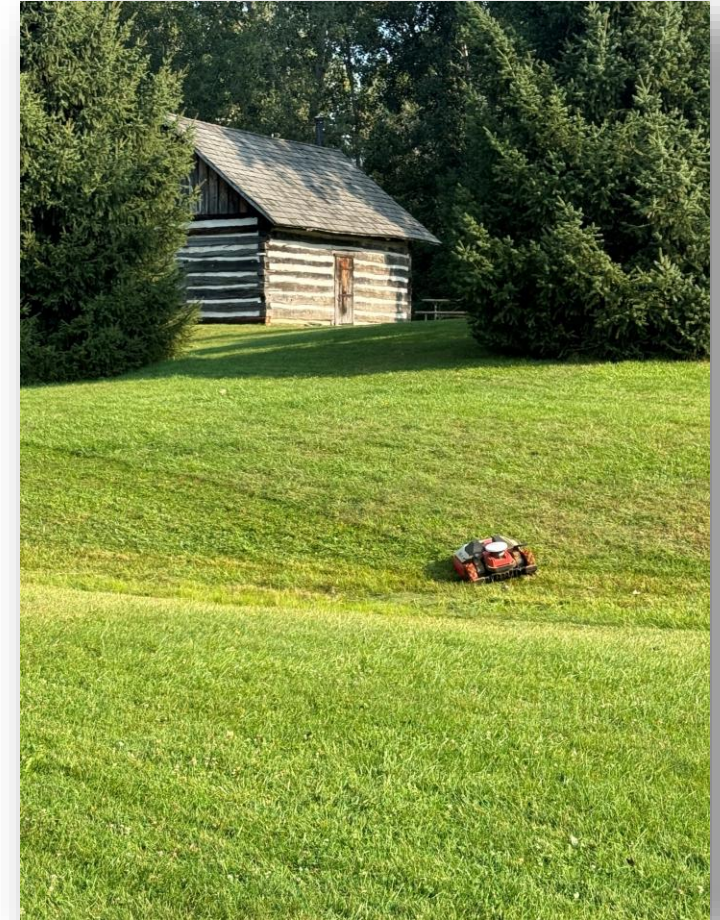

- Parking lot expansions at Hartrick, North Meridian, and Harris Nature Center Parks





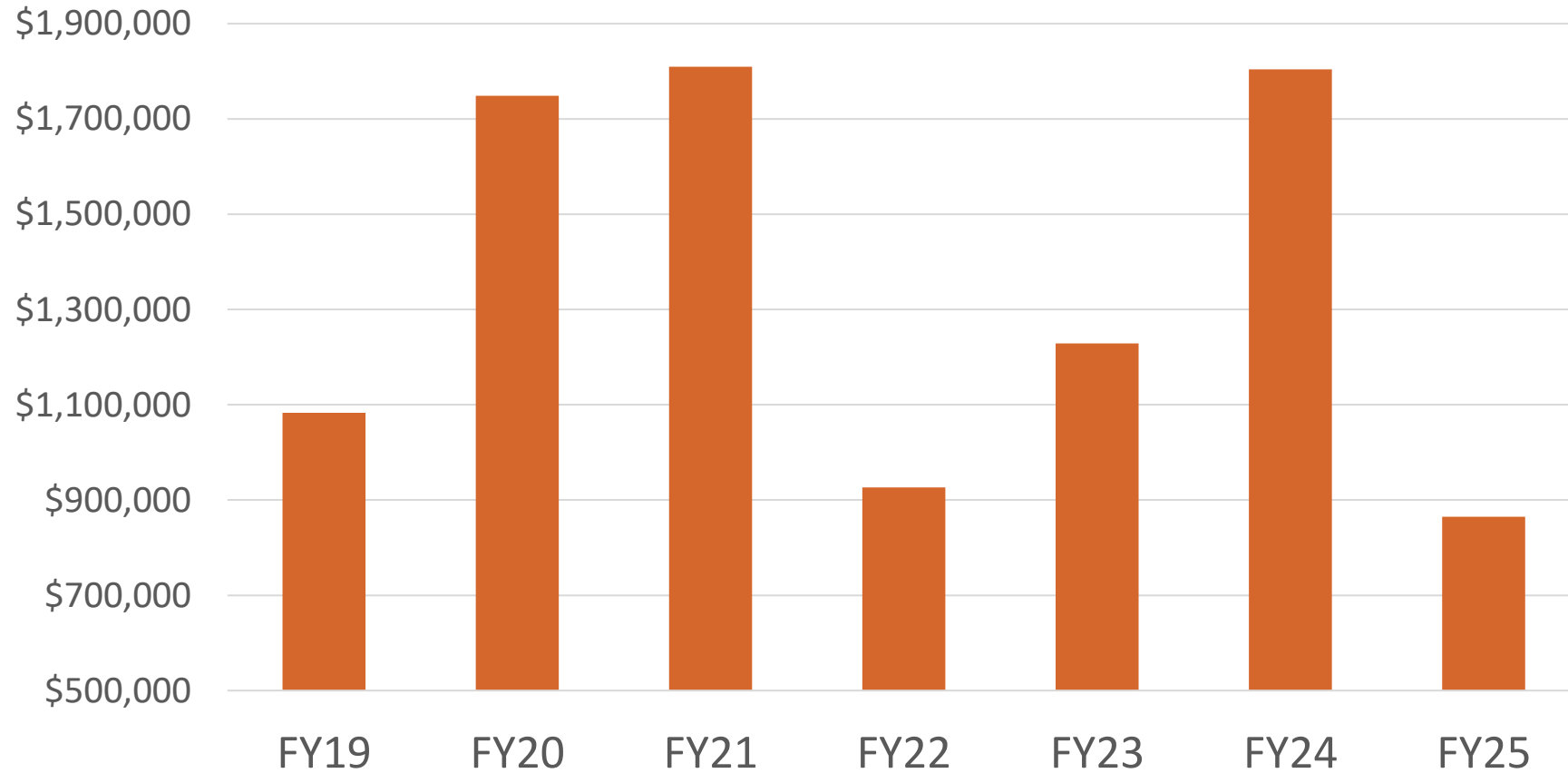
