01/01 On the 3300 block of E. Lake Lansing Rd., traffic crash occurred involving a single vehicle and a telephone pole. Driver was arrested with an OWI upon further investigation.

01/02 On the 2000 block of W. Grand River Ave., a report for a suspicious person came in. The suspect was seen yelling racial slurs at patrons. Suspect was later found to be intoxicated and given a citation for disturbing the peace and disorderly conduct.

01/03 On the 3300 block of E. Lake Lansing Rd., two individuals were in a parking lot verbally attacking and pushing each other. Suspects have both been trespassed for life.

01/04 On the 5900 block of Marsh Rd., a simple assault occurred. Both individuals involved in the assault were arrested.
