- Work completed by a governmental subdivision or state agency costing less than \$15,000.00

INSTRUCTIONS FOR SUBMITTING APPLICATION

Incomplete or illegible forms will not be accepted. Electrical work shall not be started until the application for the permit has been filed with our office. All installations shall be in conformance with the applicable Electrical Code. No work shall be concealed until it has been inspected and approved.

Permit applications can be submitted to the Charter Township of Meridian Department of Community Planning and Development by mail or in person. We do NOT accept scanned, faxed or e-mailed copies at this time.

We accept payment by cash or check
Make checks payable to "Charter Township of Meridian".

Permit applications not submitted with the required documents or payments cannot be issued until such is provided.

DEFINITIONS OF WORK

Receptacle, Switch and Lighting Outlets - Receptacle, switch, lighting or other outlets at which current is used or controlled, except services, feeders and meters.

Lighting Fixtures - Lighting fixtures, sockets or other lamp-holding devices.
Residential Appliances - Fixed residential appliances or receptacle outlets for same, including wall mounted electric ovens; counter mounted cooking tops; electric ranges, hood fans, bath fans, self-contained room, console or through-wall air conditioners; space heaters; food waste grinders; clothes dryers; or other operated appliances not exceeding one horsepower (HP). Note: For other types of air conditioners and other motor-driven appliances having larger electrical ratings, see Power Apparatus.

Nonresidential Appliances - Residential appliances and self-contained factory wired, non-residential appliances not exceeding one horsepower (HP), Kilowatt (KW) or kilovolt-ampere (KVA), in rating including medical and dental devices; food, beverage, and ice cream cabinet; illuminated show cases; drinking fountains; vending machines; laundry machines; or other similar types of equipment. Note: For other types of air conditioners and other motor-driven appliances having larger electrical ratings, see Power Apparatus.

Power Apparatus - Motors, generators, transformers, rectifiers, synchronous, converter capacitors, industrial heating, air conditioners and heat pumps, cooking or baking equipment and other apparatus. For rating in Horsepower (HP), Kilowatts (KW) and Kilovolt-amperes (KVA) or Kilovolt-amperes-reactive (KVAR). Note: For equipment or appliances having more than one motor, transformer, heater, etc., the sum of the combined ratings may be used. These fees include all switches, circuit breakers, contactors, thermostats, relays and other directly related control equipment.

Signs, Outline Lighting and Marquees - Signs, outline lighting systems or marquees supplied from one branch circuit. Additional branch circuits within the same sign, outline lighting system or marquee.

Miscellaneous Apparatus, Conduits and Conductors - Electrical apparatus, meters, conduits and conductors for which a permit is required by for which no fee is herein set forth.

PERMIT EXPIRATION

A permit becomes invalid if the authorized work is not commenced within 180 days after issuance of the permit or if authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work. A permit will be expired and closed when no inspections are requested and/or conducted within 180 days of the date of issuance, or the date of a previous inspection. Closed permits cannot be refunded.
